



# Women’s Leadership Conference Terms of Participation & Parental Authorization

Prior to participating in the San Mateo County Women’s Leadership Conference and Women’s Hall of Fame event (the “Event”) on March 24, 2018, any minor under the age of 18 must have his or her parent or legal guardian complete this form.

## General Terms

1. The registration fee is refundable up to 30 days prior to this event.
2. During the course of the Event, staff or volunteers may take photos or videos of the Event and its participants. By signing this Terms of Participation & Parental Authorization form (the “Form”), I grant to the County of San Mateo (“County”) and its representatives the right to use my (or my minor child(ren)’s) name(s), likeness(es), image(s), voice(s), and/or appearance(s) as may be embodied in any photos, audio recordings or videos recordings taken by or made by or on behalf of the County. I agree that the County owns and may use such material without restriction and without my prior inspection or approval. Such uses include but are not limited to social media postings, email announcements, press releases, website content, and promotional or informational materials in any medium (collectively, “Authorized Use”). I acknowledge that neither my minor child(ren) nor I will receive any compensation for any Authorized Use.
3. I agree that if any portion of this form is held invalid, the remainder will continue in full legal force and effect.

## Waivers & Release

4. I release, discharge, and hold harmless the County of San Mateo, including its offices, employees, agents and representatives, from any and all claims, demands, damages, costs, expenses, loss of services, actions, and causes of action belonging to the undersigned or arising out of any act or occurrence in connection with and particularly on account of all personal injury, disability, property damage, loss of damages of any kind sustained or that may hereafter be sustained arising from or during the Event.
5. I hereby give consent for me (and/or my minor children, if applicable) to receive medical treatment which may be deemed advisable in the event of injury, accident, or illness during the Event.

## Signature & Authorization

*Signature and Authorization (for persons younger than 18 years):*

I hereby acknowledge that my minor child(ren)’s participation in this Event is voluntary and that my minor child(ren) does/do not have to participate. I also understand that my minor child(ren)’s participation in this Event carries with it certain inherent risks, and I hereby agree to accept and assume any and all risks of property damage, personal injury, or death that my minor child(ren)’s participation in this Event may entail.
